ESSE was the third specialized fair which Mr. Asim Siddiqi, Marketing Manager of Tahama Fisheries, Karachi, had attended. "An important function is to create awareness that Pakistani exporters are capable of delivering to the EU market. It's impossible, when sitting in Karachi, to gain real contact with clients: even though I send a sample, I can never see/hear the reaction, whereas here at the fair you are face to face.

"The added fact that CBI is well known in the Benelux gives us credibility and people know you are reliable"

Tahama's samples of fresh fish had only managed to get through Customs' formalities on the second day: but, even without concrete samples for the first day and a half, there had been plenty of enquiries. Most interest was shown in grouper, shark and snapper "probably because they are the best known in Europe".

Mr. Siddiqi had received support at ESSE from his brother, Mr. Rafat Siddiqi, who is based in Copenhagen and specialized in smoked fish i.e.: Caught in Pakistan and processed smoked in Denmark. The Tahama's stand was the only one at ESSE with this product, which attracted a good deal of interest (mainly for the tuna and the marlin).




